The purpose of this Cookies Policy ("Policy") is to describe, in details, the practices of GOIASA GOIATUBA ALCOOL LTDA in relation to the use of Cookies on our website <a href="https://www.goiasa.com.br">https://www.goiasa.com.br</a>. As we will describe below, we may collect Cookies from you when you, the User, visit our website or interact with us through it.

## 1. WHO ARE WE

Whenever this Cookies Policy mentions "GOIASA GOIATUBA ALCOOL LTDA", "company", "we", "us" or "our", as well as grammatical variations of the first person plural, it refers to the company GOIASA GOIATUBA ALCOOL LTDA, enrolled with the National Register of Legal Entities - CNPJ/MF No. 02.773.950/0001-84, headquartered at Rodovia GO 040 - Km 194, Access 7 km on the right - PO Box 35 - Zip Code 75600-000 - Goiatuba - GO, Brazil.

Browsing our Website, you will learn more about GOIASA GOIATUBA ALCOOL LTDA, access relevant information about our company, what we do, our commitments to you, our contact channel, in addition to, of course, finding information about our products.

GOIASA GOIATUBA ALCOOL LTDA., for the purposes of applicable data protection laws, it acts as the Controller of your personal data.



\* When we say "Controller", it means the person responsible for the treatment of personal data, which is responsible for decisions regarding the treatment. We emphasize that it is possible that two people involved in the treatment are responsible concurrently and, in this way, they will be considered as co-controllers.

\* When we say "Treatment", it means any operation or set of operations carried out with personal data or sets of personal data, such as the collection, production, reception, classification, use, access, reproduction, transmission, distribution, processing, archiving, storage, elimination, assessment or control of information, modification, communication, transfer, dissemination or extraction.

### WHAT ARE COOKIES AND HOW DO THEY WORK

Our Website uses Cookies, and similar technologies, in order to offer you the best possible service, including facilitating your navigation on our Website.

We may define Cookies as small text files that are sent to your browser when you visit and interact with any web page, including our Website, and are stored on your device, which may be a computer, smartphone or tablet, and may be accessed - unless you block or delete them - whenever you visit that website again.

Cookies are useful as they can store various types of information about your browsing on a website, depending on the nature of these Cookies, whether functional, performance, advertising, among others, as we will present below in a Section 3 of this Policy. Through Cookies it is possible to improve the efficiency of your navigation, as they allow a website to remember your access choices, such as your preferred language, an item you have previously added to a shopping cart, or even to remember links that you clicked on earlier.

Other technologies similar to Cookies, such as pixels and JavaScript, for example, may allow the collection and storage of information related to you, such as the IP address of the device you are using to access a website, the date and time of access and the name domain and host from which you access the internet. This information may be used, among other purposes, to measure traffic to a website and make it more useful and efficient.

In particular, the types of Cookies that GOIASA GOIATUBA ALCOOL LTDA may use when you browse our Website and interact with us are described in a Section 3 below.

#### WHICH COOKIES DO WE COLLECT

Cookies may be classified into two main categories: (1) "Session" cookies, which are deleted as soon as you stop browsing any page on the Internet, and (2) "Persistent" cookies, which remain stored on your computer or mobile device, and may be accessed from time to time, even that you are not accessing any website.



On our Website, we may use the following Cookies:

#### STRICTLY NECESSARY COOKIES

These are Cookies that cannot be deactivated on our systems, as they are essential for the functioning of our Website. These Cookies do not store personally identifiable information, but only general configuration data, for example for optimal display of a video, such as buffer size and screen resolution information, your browser settings to display our Website in the best way in your screen or load the Website evenly so that it remains accessible.

Attention: Our Website gives you the ability to block these Cookies. However, we would like you to know that, once blocked, some parts of our Website may not function.

#### PERFORMANCE COOKIES:

These are Cookies that allow us to count visitors and monitor traffic on our Website: they help us to know which pages are most accessed and to identify how Users move around our Website.

Attention: If you do not allow the use of these Cookies, we will not know when you have visited our Website. Therefore, we will not be able to monitor your performance.

#### **FUNCTIONAL COOKIES:**

These are Cookies that allow us to analyze the behavior of website visitors and identify the most accessed content. Through them we may also offer the option of storing your login information so that you do not have to enter it every time you access our website, for example. These Cookies help us improve our services, as they are able to ensure that Website Users access exactly the information they are looking for and that their preferences remain known to us.

Attention: We would like you to know that if you do not allow the use of these Cookies, some or all of these services on our Website may not function properly.

## **SOCIAL MEDIA COOKIES:**

These are Cookies installed by a variety of social media services that may be added to our Website in order to allow you to be able to share our content on your social networks. These Cookies are able to track your browser on other Websites and create a profile of your interests. This may affect the content and messages you access on other Websites you visit.

Attention: If you do not allow the use of these Cookies, you may not be able to use or view these sharing tools and join/like our pages using these social media tools.



## 4. THIRD-PARTY COOKIES

It is important for you to know that, through your Cookies, third parties may continue to monitor your online activities even if you are no longer using our services. We therefore recommend that you periodically review and/or delete your browsing history if you want to prevent third parties from continuing to access your information.

As it is beyond our control, GOIASA GOIATUBA ALCOOL LTDA is not responsible for the use of Third-party cookies.
